1. 6. Customs declaration and inspection: provide high-quality, fast and convenient customs declaration and inspection services for import and export enterprises. Professionally provide the following services for import and export enterprises: electronic type-in of entry and exit cargo inspection data, customs inspection of the products through agency service in the import and export statutory inspection catalog, application for certificate of origin, inspection and quarantine fee payment on behalf of the enterprises, providing inspection and quarantine services and related business consultation for enterprises, etc.

7. Cargo insurance:

I. Main insurance categories

Marine cargo transportation insurance includes three types: free from particular average, with particular average and all risks.

Overland cargo transportation insurance includes two types: land transportation risk and all risks for overland transportation.

Air cargo transportation insurance includes two types: air transportation risk and all risks for air transportation.

Postal package insurance includes two types: postal package risk and all risks for postal package.

II. Additional insurance categories

(1) Additional risks within the scope of all risks include: theft, non-delivery, fresh water and rain damage, shortage, etc. If all risks are covered, the insurers are responsible for any above additional risks.

(2) Special additional risks. Special additional risks that do not fall into the scope of all risks mainly include: import duty risk, deck risk, seller's contingent risk, Hong Kong and Macau warehousing fire risk, and insect damage risk.

(3) Special additional risks refer to war risk and strike risk.

- Pacific Glory International Logistic Corp. successfully completed the 53.2-ton overweight and oversized air freight logistics program for the first time




